4. First-aid measures

Ingestion

5. Fire-fighting measures

Flammability of the product

: May be combustible at high temperature.

Products of combustion

: Carbon oxides (CO, CO2), nitrogen oxides (NOx), sulphur oxides (SOx), phosphorus oxides (POx), calcium oxides (CaOx), zinc oxides (ZnOx), aldehydes, ketones, hydrocarbons, smoke and irritating vapours as products of incomplete combustion.

Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see section 13).
